EXHIBITOR RULES

Show Focus: All Exhibitors understand that the focus of the show is “*Promoting traditional Maine outdoor activities and crafts through education and demonstration*”. Each Exhibitor agrees to support this focus through an active role at their table space. This can be through active demonstration and/or an educational presentation, information sharing or in some way that promotes Maine outdoor activities.

Codes and Agreements: The Exhibitor agrees to abide by the (Penobscot Fly Fishers) PFF Show Rules. Exhibitor agrees to adhere to all applicable fire, utility and building codes and regulations of the facility where the Show is held. Further they agree to; the terms of all agreements between the PFF and the managers or owners of said facility; and the terms of all agreements between PFF and any other party relating to the exhibit or in the facility that would cause a difference in conditions from those approved by the insurance carriers of PFF or the owners or manages of the facility, which will increase premiums payable by any of said parties.

Space Assignments: Because of the limited number of exhibit tables available PFF will assign exhibit space on a first-come basis and based on the needs of conformity to overall layout. PFF will make a best effort to accommodate exhibitor special request, but reserves the right to change the location assignment any time prior to the exhibition dates as deemed necessary

Provided to Exhibitor: Exhibitor space will include no less that one 8 foot Table with space immediately behind the table of approximately 4 feet. This space may adjoin or abut another exhibitor and each exhibitor is to respect the space of the exhibitor to which they abut or adjoin. Each exhibitor requesting electricity will be provided access to a standard single electrical plug. Each exhibitor will have made available to them up to 2 chairs. PFF will provide up to two registrations name tags.

Exclusions: PFF retains the right to exclude or require modification of any display or demonstration that, at the discretion of PFF Cabin Fever Reliever Committee, it considers unsafe or unsuitable to the character of the PFF show.

Assignment or Sublease: Exhibitors will not sublet exhibit space or equipment provided by the PFF show, or assign space without written notice and approval of PFF.

Liability: These rules do not constitute a partnership, employer-employee relationship, joint venture or agency between PFF and exhibitor. Exhibitor agrees to indemnify, hold harmless and defend PFF Cabin Fever Reliever show, its attendees, exhibitors, participants, etc. from any liability, loss damage, cost of expense (including but not limited to interest and attorney’s fees) that the Show may incur incident to or arising directly or indirectly from, intentional or negligent acts or omission or security breach by Exhibitor or its employees or agents. Exhibitor agrees that the Show, its agents and employees and the exhibit facility will not be responsible for loss damage or destruction of any property of exhibitor or injury to exhibitor or its representative, agency, employees, Licenses or invitees.

Exhibitor shall be fully responsible to pay for any and all damages to property owned by the Exhibition Hall, its owners or managers, which results from any act or omission by Exhibitor. Exhibitors agree to defend, indemnify and hold harmless the Exhibition Hall, owners, managers, officers or directors, Agents, employees, subsidiaries and affiliates from any damages or charges resulting from Exhibitor’s use of the property.

Exhibitor’s liability should include all losses, cost, damages or expenses arising from or out of or by reason of any accident or bodily injury or other occurrences to any person or persons, including the Exhibitor, its agents, employees and business invitees which arise from or out of the Exhibitor’s occupancy and use o the exhibition premises

Cancellation or Postponement: In the event that the exposition is postponed because any occurrence not occasioned by the conduct of PFF Show or Exhibitor, whether by an act of nature, the result of war, riot, civil commotion or the conduct of any person not part to this agreement, the performance of the parties under this agreement will be excused for such period as is reasonably necessary after such occurrence to remedy the effect thereof. In the extent that such occurrence results in cancellation of the show, the obligations of the parties under this agreement will be terminated.
